

EU DECLARATION OF CONFORMITY

The toy and its parts are intended for above to 3 years children. The basic parts are from massive dried wood. These pieces are permanently fitted with metal snap fasteners by screws. The individual final parts are sold separately or in sets, under the trademarks **WOODFORMERS®** or **KLIK-KLAP®**.

The toys **WOODFORMERS®** and **KLIK-KLAP®** are documented by a set of technical documentation stored at the manufacturer. Figure 1 shows an example of a 1075-ZSI kit (Basic Set I) containing 40 parts.

7. Additional information

The whole solution consisting of the use of snap fasteners for joining parts is widely protected by the manufacturer's utility model at the Czech industrial property office - Úřad průmyslového vlastnictví, Antonína Čermáka 2a, Prague 6. In the same institution we have registered a trade mark **KLIK-KLAP**. The brand **WOODFORMERS** is a trademark of a manufacturer registered with an EUIPO agency with EU validity.

This EC declaration of conformity covers individual parts and assembled sets which have been manufactured under the supervision and with the manufacturer's approval.

Restriction of statements – the manufacturer assumes no liability for any imitations and products made/marked without its permission from third parties, thereby also violating the utility model right, even the manufacturer's trademarks.

Packaging - boxes, instructions, or any plastic parts of the packaging (plastic window, plastic wrapping of retail packaging, ...) are not intended for play, so they are not subject to testing and verification for toys, nonetheless health-conscious materials are selected.
